Alexis L. Cirel is rejoining SSRGA, where she was a partner from 2019-2021. **Cirel** played an instrumental role in the passage of the Child-Parent Security Act, which legalized surrogacy in New York, and served on the Campaign Leadership Committee for Governor Andrew Cuomo's efforts in support of the revolutionary legislation. She is one of approximately 200 attorneys in the country to receive the distinction of being named an Assisted Reproductive Technologies Fellow of the Academy of Adoption and Assisted Reproduction Attorneys, and serves as the co-chair of the Legal Ethics Committee for the Society for Ethical Egg Donation and Surrogacy, Co-Chair of the New York State Bar Association's Surrogacy Subcommittee, and is a member of the American Society of Reproductive Medicine's Legal Professionals Group.

"I am elated to return to SSRGA and lead this dynamic new practice", **Alexis L. Cirel** added. "The establishment of this group reflects the firm's commitment to addressing the evolving legal needs of modern families." **Eric I. Wrubel** joins SSRGA as a partner. He is the immediate Past President of the New York Chapter of the American Academy of Matrimonial Lawyers (AAML) and is a fellow of the International Academy of Family Lawyers. He is recognized as a leader in the re-definition of family in New York, where his groundbreaking win in the New York Court of Appeals' case, In the *Matter of Brooke S.B. v. Elizabeth A.C.C.*, expanded the definition of "parent" to include same-sex couples. The *Brooke* decision led to New York Appellate Courts then applying for the first time the presumption of legitimacy to children born during same-sex marriage.

Wrubel is consistently at the forefront of same-gender marriage and divorce issues and lectures frequently on issues of parentage, including tri-parenting. He regularly consults on embryo disputes and argued a leading case in New York that led to the return of children conceived through IVF to their biological parents. He is often consulted on the impact of U.S. Supreme Court decisions on family formation.

Rose H. Vacanti Gilroy joins SSRGA as an associate. She is licensed in New York, Connecticut, and New Jersey. In addition to maintaining a burgeoning matrimonial practice, she handles complex parentage establishment matters, surrogacy and donor arrangements, and issues specifically facing LGBTQ+ individuals. She is a graduate of Georgetown University Law Center.
